

## **The National Free Wills Network**

The Macular Society's membership of the National Free Wills Network means we can offer members and supporters aged 55 or over a simple Will or pair of mirror Wills for free. The Wills are made via a local solicitor chosen from a network of over 800 firms throughout the UK. Once a Will is made, the Macular Society pays a discounted fixed fee to the participating solicitor.

There is no obligation to leave a gift in your Will to the Macular Society. However, we very much hope that, after taking care of your loved ones, this is something you will wish to do. If so, you'll be supporting vital research to find new treatments and a cure for macular disease, and helping us provide much-needed support and advice so that no-one faces macular disease alone. **A gift in your Will, large or small, would truly help us beat macular disease for good.**

To take part in this limited offer, which is open on a first come first served basis, you must first register your interest with the Macular Society. We will share your details with the Network and their agent Capacity Marketing for Charities. You can find information on how we look after your data at the end of this document.

The Network will send you a large print information pack on how to get your Will made for free. This will include details of local participating solicitors and a yellow Confidential Declaration Form. You choose a firm of solicitors from the list and call them to make your appointment, being sure to mention the National Free Wills Network. Take the yellow Confidential Declaration form with you to your appointment, as in order to claim your free Will, this needs to be completed and given to your solicitor once your Will is written.

If, during your appointment, it becomes apparent that your needs are more complex, your solicitor will discuss this with you and advise you of any additional cost involved in providing further legal advice. It is up to you to decide whether to proceed at this stage. If you do, the Society will still cover the basic cost of a simple Will but you will pay for any extra advice you have agreed to.

We will be informed by the Network if you have kindly remembered us in your Will and we will contact you to say a very warm thank you.
